Letter of Permission for admission and continuation of 3rd and 4th Year B.V.Sc &A.H. programme during 2019-20 and 2020-21 at Apollo College of Veterinary Medicine, Jaipur affiliated under Rajasthan University of Veterinary and Animal Sciences, Bikaner, Rajasthan.

Sir,

I am directed to refer to the letter No.03 (14)/ACVM/Acad. /VCI – GoI/2018/449 dated 18.08.2018 on the above subject and state that it, alongwith the Inspection Report as requested under the MSVE Regulations, 2016, were considered by the Advisory Committee constituted under Rule 16 of Veterinary Council of India (Procedure of recognition and de-recognition of Veterinary Colleges and Veterinary Qualification) Rules, 2017. The Advisory Committee has mentioned in their recommendation dated 27.12.2018 inter alia,

"The committee recommended permission for continuation of the third and fourth year in the Apollo College of Veterinary Medicine, Jaipur, affiliated under the Rajasthan University of Veterinary and Animal Sciences, Bikaner. The faculty required for the 4th year shall be employed before start of 4th year".

The recommendations of the Advisory Committee have been considered by the Competent Authority in the Central Government subject to the outcome of the appeal with Commissioner, Department of Devsthan, Rajasthan . Accordingly, Apollo College of Veterinary Medicine, Jaipur affiliated under Rajasthan University of Veterinary and Animal Sciences, Bikaner is granted permission as per Veterinary Council of India (Procedure of recognition and de-recognition of Veterinary Colleges and Veterinary Qualification) Rules, 2017 to admit students upto 80 (eighty) during 2019-20 and 2020-21 and to continue the teaching programme for the Third and Fourth year only.

However, no teaching programme for the Fourth year of the B.V.Sc & A.H. course should be taken up until:

(i) the Institute complies with the requirement of faculty and infrastructure as per MSVE Regulations, 2016 two months prior to start of the Fourth year academic session and

(ii) obtaining specific approval to conduct the Fourth year B.V.Sc & A.H course by the Competent Authority of Central Government.
